**ONLINE VERIFICATION OF RESERVED CATEGORY DOCUMENTS DURING
CENTRALIZED ONLINE COUNSELLING: ACADEMIC SESSION 2022-23**

The process of Enrolment for Centralized Online Process of Counselling and Online Verification of Reserved Category Documents has commenced. It is stated that the online verification of reserved category documents is carried out only based on the information / documents / entitlement card supplied by the candidate himself / herself only.

It is noted that, some of the candidates who are claiming reservation for particular reserved category, have not uploaded the relevant valid certificate to substantiate his/her claim in that particular category.

It is further informed that in the absence of the authentic and valid document with respect to claimed reserved category, the candidate shall not be considered as a reserved category candidate, but shall be converted as a General Category candidate. Also, their verification of documents for reserved category is provisional and is subject to production of the authentic document at the time of reporting at their allotted College/ Institute.

If any certificate/ document, based on which, if the admission has been granted, is found fake/ invalid, the admission of the candidate shall be cancelled even at the later stage. Hence, it is the responsibility of the candidates themselves to ensure that, they choose the correct Reserved Category, Region and upload the relevant document towards claim of their candidature to reserved category. Incorrectness of Region / Category/ any other relevant information may lead to cancellation of admission.

With respect to "Region", the definition of "Delhi Region Candidate" and "Outside Delhi Candidate" is elaborated in "Chapter 5: Seat Allocation" in Admission Brochure 2022-23.

The same is reproduced here below:-

“Delhi Region 85% of the Sanctioned Intake.”


The candidates shall be considered as Delhi Region Candidates if they have passed the qualifying examination from any school / institute located in NCT of Delhi or from any college / institute affiliated to GGSIP University. All such candidates shall be notified as “Delhi Region Candidates” for the purpose of counseling for admission.

“Outside Delhi Region 15% of the Sanctioned Intake.”

The candidates shall be considered as Outside Delhi Region Candidates if they have passed the qualifying examination from any school / institute located Outside Delhi. All such candidates shall be notified as “Outside Delhi Region Candidates” for the purpose of counseling for admission.”


All the candidates are advised to fill up correct Region and enclose the correct document while enrolment for Centralized Online Process of Counselling.
